Additional Comments: This paper examines the relationship between labor market rigidity and FDI decisions by Europeans multi-nationals firms during 2004-2008. We use firm-level data for European Multinational Enterprises investment in 41 European countries during these four years.

Using conditional fixed effect logit and Tobit estimations, we show that European MNEs generally respond to regulatory, gravity and firm specific indicators in the expected ways, but their responses to changes in labor market institutions are less consistent. We also find that the relationship between MNEs location decision and host country's labor market institutional factors is sensitive to host country's development stage and market integration with the EU countries.

Additional Comments: Recent empirical studies show that interest rate fluctuations play an important role in the movements of cross-border bank capital flows through the adjustments of banking sector leverage. However, banking institutions' decisions regarding leverage adjustments are also influenced by news related to economic fundamentals across the borders. In this paper, we investigate the spillover effects of macroeconomic news on cross-border bank capital flows and the US dollar exchange rate through the banking sector. Using the maximum forecast error variance approach, we identified news shocks regarding economic fundamentals from the slopes of yield curves, which represented the spread between the yield on a long-term US Treasury bond and a short-term bill rate. We found that favorable news shocks in the US economy led to a decrease in cross-border banking capital flows. Such capital inflows took place through international banking channels and resulted in the appreciation of the US dollar.
