- RC 5309 Advanced Respiratory Care Practice (ONLINE). This course is an exploration of advanced Respiratory Care topics to optimize practice in the healthcare environment. The coursewill address best practice recommendations and evidence-based research to enhance and expand the role of respiratory therapists. Topics will be presented through a translational medicine lens to bridge the gap between theory and practice. **NOTE**: Course submitted as a new MSRC addition. Completed College Curriculum Committee Review (10/14/2022). Completed University Curriculum Committee Review (01/27/2023).
- RC 5311 Advanced Mechanical Ventilation Practice (ONLINE). This course is an exploration of advanced mechanical ventilation in the acute care setting. This course will consist of indepth reviewof current and emerging mechanical ventilation strategy and protocol. Mechanical ventilation content will be focused on invasive andnon-invasive support mechanisms with a goal of bridging theory and practice. Evidence-based research, patient case studies, andvideo waveform analysis will be used to reinforce learning. **NOTE**: Course submitted as a new MSRC addition. Completed College Curriculum Committee Review (10/14/2022). Completed University Curriculum Committee Review (01/27/2023).
- RC 5316 Respiratory Care Curriculum Development (ONLINE). This course prepares the respiratory therapist for a role as an educator in an academic and industry setting. The course focuseson building foundational knowledge of respiratory care curriculum and instruction. Topics include adult learning theory, writingobjectives, online and in-person instruction, exam preparation, item analysis, and providing feedback. National organizationcurriculum recommendations will be integrated into the course content.

  NOTE: Course submitted as a new MSRC addition. Completed College Curriculum Committee Review (10/14/2022). Completed University Curriculum Committee Review (01/27/2023).
- RC 5302 Clinical Practice Guidelines and Respiratory Care Protocols (ONLINE). An examination of the roles of clinical practice guidelines and protocols in the continuum of patient care. Analysis of the development, modification, initiation, and evaluation of patient outcomes will be covered. Barriers to protocol practice and strategies for implementation will be explored. Evidence-based outcomes will be summarized through literature reviews.
- RC 5304 Cardiopulmonary Disease Patient Education (ONLINE). A comprehensive study of patient education and self-management of cardiopulmonary disease exacerbations including disease information, prevention, and treatment. Programs for patient self-assessment, treatment efficiency, adjustment of drug regimen, behavior modification, and nicotine addiction will be examined. Methods for documenting outcomes and patient behavior modification will be covered.
- RC 5214 Sleep Staging and Diagnostics (ONLINE). Introduction to the staging of sleep for adults, children and infants will be covered. EEG, EOG, EMG, respiratory event,

- movement events, arousals and cardiac events will be reviewed. Intensive study of the AASM Scoring Manual will guide all aspects of the course. Course design and production with Instructional Technologies occurred in 2017. Field test during the Spring 2018 semester.
- RC 5215 Clinical Polysomnography-Sleep Staging (ONLINE). Advanced clinical education in sleep staging rules, light, delta and REM sleep scoring and analysis in a sleep lab. EEG, EMG, ECG and respiratory events will be discussed in depth along with components of the polysomnogram report. This course was revamped to be delivered online for the Polysomnography specialty track for the Master of Science in Respiratory Care (MSRC). Course design with Instructional Technologies occurred in 2017. Production during spring 2018 and field test during the summer 2018.
- RC5308 Advanced Therapeutics and Diagnostics (ONLINE). An overview of advanced cardiopulmonary diagnostic and therapeutic procedures addressing selected disorders including asthma, chronic obstructive lung diseases, restrictive lung diseases, pulmonary edema, congestive heart failure, and cardiac disorders. International disease standards and classifications established by the World Health Organization with appropriate treatment protocols will be discussed. This course was developed for the Master of Science in Respiratory Care (MSRC). Course design with Instructional Technologies occurred in spring 2018, production in summer 2018 and field test in fall 2018.
- RC5310 Fundamentals of Sleep Medicine (ONLINE). Introduction to the physiology of sleep including sleep neurology, sleep architecture, and classification of sleep disorders. Review of basic cardiac physiology and ECG arrhythmia recognition. This course was revamped to be delivered online for the Polysomnography specialty track for the Master of Science in Respiratory Care (MSRC). Course design and production with Instructional Technologies occurred in 2017. Field test during the Spring 2018 semester.
- RC 5313 Polysomnography Therapeutic Intervention (ONLINE). In-depth study of the treatments available for sleep apnea including CPAP, BiPAP, oxygen therapy, patient adjunctive fitting, surgical intervention and the role of the sleep tech in titration. Special attention will be given titration algorithms, nocturnal seizure disorder studies, REM behavior disorder studies, MSLT's and MWT's. This course was revamped to be delivered online for the Polysomnography specialty track for the Master of Science in Respiratory Care (MSRC). Course design and production with Instructional Technologies occurred in 2017. Field test during the Spring 2018 semester.
- RC 5215 Clinical Polysomnography-Sleep Staging II. Advanced clinical education in sleep staging rules, light, delta and REM sleep scoring and analysis. EEG, EMG, ECG and respiratory events will be discussed in depth are components of the polysomnogram report. A research project and presentation will be assigned by the faculty.
- RC 5310 Fundamentals of Polysomnography. This course was designed to explain the fundaments of polysomnography and polysomnography testing. Exploration of sleep staging and event scoring per the AASM guidelines are covered.

- RC 5312 Clinical Polysomnography-Sleep Staging I. Direct patient diagnostic monitoring is performed under close supervision in a sleep lab. Differential amplifiers, amplifier calibration, artifact correction and the professional role of the sleep tech will be demonstrated. A research project and presentation are assigned.
- RC 5313 Polysomnography Therapeutic Intervention. This course was designed to review the therapeutic modalities and procedures for diagnostic and treatment polysomnography. Lectures were prepared in assistance with the assigned faculty Lynda Harkins.
- RC 4333 Neonatal Critical Care This course will provide the Respiratory Care student with advanced knowledge on the management of the neonatal patient in the critical care environment. The course will expose the student to advanced therapeutics and mechanical ventilation strategies. Course content will prepare the student for the role of neonatal specialist. Course part of the BSRC-Online curriculum.
- RC 4322 Respiratory Care Seminar. Assisted in the development and teaching. Respiratory care students, working in a small group, engage in intense research of an assigned patient case study. The output of this research will take the form of a major paper and presentation to an audience of fellow respiratory care students and a pulmonary physician. The course is designed to allow dialogue between the student presenters, the pulmonary physician and other respiratory care students.
- RC 4320 Contemporary Issues in Cardiopulmonary Care/Advanced Cardiac Life Support/Polysomnography. Students participate in managing cardiac arrest and life-threatening arrhythmia scenarios and receive instruction on sleep disorders and sleep study procedures.
- RC 4316 Respiratory Care Practice IV. Advanced clinical education in the intensive care setting in which the student monitors and administers critical care therapeutics on assigned patients in the adult, and neonatal intensive care units.
- RC 4309 Pulmonary Diagnostics An overview of cardiopulmonary diagnostic procedures addressing selected disorders including asthma, chronic obstructive lung diseases, restrictive lung diseases, pulmonary edema, congestive heart failure, and cardiac disorders. Course part of the BSRC-Online curriculum.
- RC 4225 Specialization Internship. This course is intended to build skills in a sub-specialty area. Respiratory care students spend 160 hours orienting and working in an area of their choice pending departmental approval. Options include: Management, Education/Research, Home care, Sub-acute care, Pulmonary Rehabilitation, Adult intensive care, Pediatric intensive care, Neonatal intensive care, Polysomnography.
- RC 4223 ICU Internship. Advanced clinical education in the intensive care setting in which the student monitors and administers critical care therapeutics on assigned patients in the

- adult intensive care setting. Physician input and pulmonary rounds assist the student in theory and application of care for the critically ill patient.
- RC 4212 Critical Care Clinical Simulation. This course prepares the respiratory care students to successfully navigate multiple clinical simulation patient cases. Clinical simulations covered reflect real-life patient scenarios and mirror the content found on national board exams. Students receive focused attention on board exam review (written and clinical simulation) and evidence-based care.
- RC 3334 Neonatal Respiratory Care. This class was developed to familiarize students with the proper care of the neonatal and pediatric patient population. Course curriculum was designed to prepare students for success on the Neonatal/Pediatric Specialty Exam.
- RC 3333 Respiratory Care Practice III. A supervised clinical education experience in which the student organizes and administers advanced respiratory therapeutics on assigned patients in adult critical care. Procedures include arterial blood gas procurement and measurement, bedside physiologic monitoring, airway care, as well as setup, monitoring and maintenance of mechanical ventilators.
- RC 3323 Respiratory Care Practice II. Student gains skill in clinical procedures, interaction with patients and professional personnel as he/she administers respiratory therapy under supervision in a health care setting. The student will become familiar with various RC aspects of patient care as presented in medical/surgical/trauma situations.
- RC 3313 Clinical Practice I. Introduction to clinical skills, including vital signs, chest assessment, infection control, aerosolized medication delivery, oxygen therapy, hyperinflation therapy, airway clearance, etc. This course prepares the student for direct patient care to be performed in more advanced courses. All procedures are performed under close supervision.
